***Please Note:**

Buses will wait for five (5) minutes after arriving at the designated stop. Students who have not been picked up will be brought back to school and it will be the responsibility of the parent to pick that student up at BCS. Fees will apply until they are picked up and students brought back to school more than once may lose their school bus privileges.

Riding the school bus is a **PRIVILEGE**, not a right. Students are expected to conduct themselves in a well-behaved manner while riding school buses. BCS reserves the right to remove any student whose behavior is detrimental to the safety of other students riding the bus and/or the driver. Students who misbehave on the bus will be denied the right to ride the bus for a specified period of time, typically ranging from one to ten days. Repeated misconduct may be grounds for permanent suspension of school bus privileges. This includes safe and appropriate behavior during pick-up and drop-off at satellite parking lots. Parents/Guardians who have concerns about behavior or the safety of students riding the bus should contact school administration immediately.

PARENT/GUARDIAN CAR SAFETY INFORMATION FOR SATELLITE PARKING LOTS

- Please park in designated spaces only.
- If your car and driving safety is in question, administration may ask you to make other arrangements for your student(s).
- **Wait until all students have loaded and unloaded before exiting the satellite parking lot.** For the safety of all students, please exit the parking lot in the opposite direction from where the buses are parked and be watchful of students who may still be walking to the bus or their car.
- **Please do not use any electronic devices while driving into and leaving the satellite parking lot (i.e. cell phones, texting, eReaders, iPods, smart watches, etc.).** Your attention during this time is vital for the safety of our students, staff, and families.
- Do not drive in student walking areas in the satellite parking lot. Park your vehicle and maintain a safe distance from all students.
- **Bus drivers CANNOT pick up students outside of the area in which they are parked, with their engine off.**
- If there are concerns with unsafe drivers or parking, please record the make, model, color, and license plate of the car. Contact the BCS office and notify them of this information and your concern.

2020-2021 BUS TRANSPORTATION AGREEMENT (Revised 7/30/2020)

- North Carolina Public School Law states the “driver of any school bus shall permit no person to ride upon such bus except pupils or school employees.” Only school personnel and BCS students may enter and board any BCS school bus. In all other cases (i.e. field trips, athletic trips, etc.), administrative approval is required.

EXPECTATIONS OF ALL STUDENTS RIDING THE SCHOOL BUS:

- All riders will be seated and will not move from seat to seat.
- Damage to seats will result in the student being responsible for repairs.
- Aisles are to be clear of book bags, musical instruments, athletic bags and equipment, etc.
- Food, drink, and tobacco products are not permitted on the school bus.
- Students are not to be excessively loud.
- Profanity, inappropriate language, and inappropriate gestures will not be tolerated.
- Students are not to yell at pedestrians or other vehicles.
- Students will not throw objects from the school bus.
- **All electronic devices must be turned off while on the school bus.**

Parents/Guardians will be contacted regarding students who are reported for on the school bus. Students who display inappropriate conduct on the school bus will be subject to disciplinary action, which may include suspension from the school bus for a specified period of time or, in repetitive or serious cases, permanent removal from the school bus.
